As one of the most important judicial events in Bosnia and Herzegovina, this year's Forum will be dedicated to the role of the highest courts and the Constitutional Court of Bosnia and Herzegovina in the harmonisation of case law in prosecuting organised crime and corruption cases.

Judges, prosecutors and other legal experts will discuss the European standards, particularly Articles 5, 6 and 8 of the European Convention on Human Rights. The Forum will also open a discussion about the new challenges of criminal offences related to the development of technology, including cyber-crime, as well as the (ab)use of technologies for money laundering, trafficking in arms and narcotic drugs, and other acts of organized crime.
